

A meeting of the Governing Body of Dharmasala Mahavidyalaya was held in the presence of the following signatories under the chairmanship of Hon'ble Sub-Collector-cum-President in his office chambers at 4pm on 11.12.2020. The following discussions were held and the decisions were arrived at unanimously that :

1. Retirement of Prof. Shubhramshu Kumar Pattanayak as Principal-in-charge on dated 30.9.2020 was approved.

4. Vacancy is prevailing in the post of Sweeper as the person working against D.P. post was retired on 30.6.2020. As it is an essential post for the smooth maintenance of sanitation and hygiene of the College, it was decided to engage a sweeper on contractual basis out of the funds available in Development/Improvement fees of the College following due procedure and intimate the President for his kind approval.

Principal was empowered to do the needful following the procedure of the Govt. from time to time.



Keeping the view of vacancy it was decided to engage one Matron and one Security Guard on contractual basis out of the funds available in the Development/Improvement fees of the College.

Principal was authorised to take necessary steps following due procedure and intimate President for his approval.

Considering the ultimatum from Commissioner, EPF vide letter No. 2186, dated 20/11/2020, it was decided to regularise the matter and Principal was advised to do the needful.

At last the chair was thanked and meeting was dissolved.
