

Sitting No. 115 / Dt. 31-03-2022

A meeting of the Governing Body of Dharmasala Mahavidyalaya was held in the office of the Sub-collector, Jaipur on dt. 31-03-2022 at 11:00 A.M. under the chairmanship of sub-collector-cum-president, Dharmasala Mahavidyalaya. Discussion regarding different matters of the college were held and the following decisions were taken accordingly.

1. At the outset principal informed about the order of Higher Education, vide letter No. 41317 / dt. 11-10-2021 regarding transfer of Sri Pradip Parida, Lecturer-in-Logic & Philosophy of U.N.S. Mahavidyalaya against Sri Santosh Kumar Dash, Reader-in-Philosophy, Dharmasala Mahavidyalaya. Accordingly Sri Santosh Kumar Dash relieved on dt. 16-10-2021 and Sri Pradip Parida joined on dt. 22-10-2021 and it was approved.
2. Principal put forth the engagement of Sri Satyasagar Mohanty, P.E.T. on dt. 01-11-2021 on contractual basis for the session 2021-22 whose selection was made abiding due procedure i.e. advertisement and interview.
3. Principal placed the audit report for the financial year 2020-21 for discussion. Regarding audit compliance it was decided to recover the outstanding amounts. Accordingly the audit clearance cum no-objection certificate issued to Ex-Principal Sri Subhanshu Kumar Pattanaik as per the file order of the President, G.A. dt. 18-01-2022 was approved.
4. Sri Atulya Kumar Rath, LDC retired on dt. 31-01-2022, Sri Santosh Kumar Das, UDC & Sri Manoranjan Jena, LDC retired on dt. 31-03-2022. Retirement of the above staffs was approved.
5. There are four numbers of clerks and four numbers of peon posts lying vacant, it is very difficult to run the office. Keeping in view the vacancies it was decided that at least two numbers of clerks and one peon are barely required to manage the official work. Principal was authorized to take steps to engage two clerks and one peon on contractual basis for the session 2021-22 maintaining due procedure.
6. As per Govt. letter No. 1954 / dt. 25-11-2021 it was decided to change the ROR of land of the college in the name of the Department of Higher Education, Govt. of Odisha Market Principal, Dharmasala Mahavidyalaya

following due procedure:

- 7- As per Govt. letter No. 2357/Dt. 04.10.2021 of SPD, DHEPEE, Govt. of Odisha and considering the electrical load factors for the new buildings, it was decided to install a new 3 phase electrical transformer for the college. The principal was authorized to do the needful observing the formalities of Govt.
- 8- Principal intimated the nomination of the President Dr. Priyanath Mahapatra to the Governing Body, Dharmasala Mahavidyalaya as per Govt. Letter No. 47140/HE/Dt. 20.11.2021. Sub-collector-cum-President instructed the principal to prepare a list of members to send for approval as per the procedure with consultation of the newly nominated President.
9. Sri Sushante Kumar Samal, DEO is working in SAMS (both for +2 & +3) of the college. As per Govt. Order No. 39174/Dt. 17.11.2024 and Governing Body Resolution No. 104/Dt. 14.08.2026 he was getting total remuneration Rs. 9000/- per month. But as per Govt. Order No. 19684/Dt. 04.07.2018 his remuneration has been enhanced to Rs. 12000/- per month. It was discussed and approved. ~~with retrospective effect.~~
- 10- As all the approved employees have retired attending their superannuation from the library and no skilled class-IV (peons) employees available in the college to work as Library Attendant, it was decided that Sri Bidyadhar Behera, Laboratory attendant in chemistry will be assigned the duty of Library Attendant and Sri Bankarsan Baral, peon will work as Laboratory Attendant in place of Sri Bidyadhar Behera till suitable alternative arrangement.
- 11- After completion of six years, the service of Sri Yashobanta Sethy has been regularized vide G.B. Resolution No. 114/Dt. 21.09.2021. Now as per Govt. Order No. 12665/Dt. 23.03.2022 Govt. has been pleased to convey the approval for regularization of his service and he is eligible to get his salary in the admissible of the pay in the prescribed pay matrix as per ORSP rule 2014. Accordingly his pay was fixed in the scale of pay Rs. 19900/- w.e.b. dt. 19.06.2021 and it was approved.
